#### System Report:

Libraries were encouraged to do non-fiction weeding. Dec.11 is the new date set for the Dec. Systems meeting. Vaneesa, Nancy and Harriet will attend the Nov. Systems meeting.

## Librarian's Report:

Circulation for September, 2002 was 1,926 as compared to 1,657 for September 2001. Collection expenditures to date: 8,426.41. Carol has posted a sign in the library: No chatrooms, No games, and No Instant Messenger. These items fall under our policy for internet access.

The Story Rider from Systems is coming to the library every other Wednesday, at 2:15, for a Parent/Toddler Lap-sit Program. Our upcoming program Mock Turtle Marionette Theatre is a joint venture with the Robesonia Library and will be held Nov. 5 at the Middle School. N. Chamberlain will set up a table at the school to distribute library information. Carol was asked for suggestions to spend extra funds, if there

are any. Her Wish List items include a new computer and new carpting for the Board Room.

Unfinished Business:

Harriet has received a copy of the Borough Grant application.

### Building Committee Report:

Nancy and Harriet met with Curtis Moore to discuss the 65,000 State Keystone Grant. There will not be a dispersement of this Grant until 2004. There is a tremendous amount of work involved with this Grant but C. Moore is qualified to help us through the process. The Board discussed making a commitment to building improvement and applying for the Keystone Grant. D. Beamesderfer moved to commit to Building Improvements and applying for the Keystone Grant. V. Cook seconded; motion passed. H. Grimes moved to hire C. Moore as our Library Consultant @ 1,000; N. Chamberlain seconded. Motion passed. Nancy and Harriet must give a building proposal to Borough Council so they may check with the Building Engineer to verify proper support for book weight.

# Teen Discussion Group:

Board members recommended advertising in Voices, by announcements at school, and by distributing flyers and posters around town.

The Systems Award Nomination for La Rue was read by Dian. Harriet and Kathy will write and submit an award nomination for Carol.

- C. Edwards has ordered name badges for library volunteers and staff.
- H. Grimes recommended Volunteer Training sessions and workshops be held in the Spring for new volunteers and Board members.

### New Business:

Dian and Kathy will evaluate Carol for Director Performance. Carolyn will mail invitations to key people for the Xmas Tea. To commemorate the 250 Anniversary of Berks County, Harriet suggested having an Adult Writing Contest in Feb. 2003. Participants would write anecdotal items about their experiences in Womelsdorf. The best stories might be published in a book. N. Chamberlain will contact The Rotary Club to check into a possible Grant.
