Old Business

Lease Agreement

- This topic was moved up to be sure there would be enough time for discussion. Leslie spoke with Dave Bright, he was unable to give any extra information regarding the library code statement. Through Liz, Leslie was told that Harvey said that it had to do with keeping the library board at 5-7 people. Concern was expressed that this was not directly from Harvey. The suggestion was made to continue to be vigilant, going to Borough Council meetings and staying current on everything they are doing. As this situation began, the Borough Council stopped funding, and only resumed funding with stipulations.
 - Storage closet comment in lease—says that we need to discuss a new location for some of the library tables. Suggestion was made to get different chairs that stack differently, thinking that the issue isn't the tables but the chairs and their racks. The reverse was argued, since the chairs are used for the Borough Council meetings. Apparently there are problems getting into the storage closet—Friends of the Library will discuss this with maintenance.
